

## Data Analysis – What does the School Report Card & Benchmarking data tell you about student performance in your school?

### School Report:

The attendance rate at Northwest has increased from 90 to 91 percent. The attendance rate at Northwest has declined from a steady 94 percent from COVID. We are currently working with families and truancy to increase our attendance rate. We have switched from having the Regional Office of Education sending truancy letters to families to sending the first two truancy letters ourselves. This has allowed us to work with families to find solutions on how to increase student attendance. The mobility rate at Northwest dropped from 15 percent to 10 percent over the past year. This has also assisted in increasing our overall student attendance rate. Northwest continues to have a large percentage of White, Non-Hispanic students. This data is current with other schools in Lincoln Elementary School District #27. Northwest has a current enrollment of two hundred fifty-six students.

### Benchmarking Data:

We continue to use STAR360 as our benchmarking tool. The data that is provided is based on the Winter 2023 benchmarking period. The students in kindergarten and first grade were administered the Star Early Literacy Test, while all other students at Northwest were administered the Star Reading Test. We are still working to determine how students will do on the IAR test based on the STAR Test. The students in kindergarten and first grade appear to do better on the STAR Early Literacy test, and we see a decline in performance on the STAR Reading Test. We hope that the changes to the reading curriculum will show an improvement in reading scores. All first through fifth-grade students took the STAR Math test. The students have been more successful with the STAR Math test than the reading test. Students are scoring between fifty and seventy-six percent on grade-level. We continue to use Problem Solving Data to pinpoint students that are struggling with grade-level curriculum.

### IAR:

Northwest students and staff are working to improve IAR test scores. The data trends are still inconsistent, and we still continue to gain traction since COVID. There has been an emphasis placed on reading and math data for all students. We have several concerns about our third and fourth grade reading scores. We are hoping that with the introduction and consistency of our new CKLA Reading Curriculum that we will see a net gain in readings scores across each of the grade levels. We are also working on improving the math scores. We hope with an increase in student attendance and a return to more “normal” school conditions our students will be better prepared for the Illinois Assessment of Readiness.

**Data Analysis – What does the behavior data tell you about your school?**

The majority of the behavior infractions were caused by a small group of fifth graders at recess. There was an increase in the number of recess incidents during the fourth and fifth grade recess. We have added additional staff to our 2023-2024 fourth and fifth grade recess. The number of suspensions for the 2023-2024 school year have declined drastically from last year.

#### Educator Support – What types of professional development are offered to help teachers continue to meet student needs?

Lincoln Elementary School District #27 offers four days of professional development throughout each school year. The district also uses early dismissals each month as in-house professional development opportunities. The district uses resources from Tri-County to provide professional development as well. We are currently using Educational Impact to provide professional development on the Danielson Teacher Evaluation Model. We have two instructional coaches that service the K-5 teachers in the district. The district also uses grade-level collaboration days to allow each grade level time to plan. The district has focused on technology professional development for the past several years. The teachers have received training on how to use Promethean Boards, Chromebooks, and several types of software. It is critical for our staff to understand how to use the technology and the benefits for student learning. We have also partnered with Lincoln Memorial Hospital to incorporate the CATCH program. This is a program that works to promote healthy eating and physical activity to combat the growing obesity rate in Logan County.

#### Interventions – Describe intervention strategies provided to students.

We have a Problem Solving Team meeting every six weeks to discuss students that are struggling in the classroom academically or behaviorally. The team is composed of two regular education teachers, special education teacher, school psychologist, special education coordinator, and the school principal. The Problem Solving Team works with the regular education teacher and parents to develop a plan to address the deficit areas. We identify the area of weakness and start the student in an intervention. The intervention depends on the student and deficit area. We have incorporated the use of the special education teacher in our Problem Solving meetings because they provide the best knowledge in developing action plans and interventions for the students. We use Lexia, IXL Math, SRA, and other research based interventions. Reading Recovery is also offered for students in first grade that need additional assistance in reading.

#### Student Services – Describe services available to students and families.

There are several programs that are available to the students and families. Northwest staff host an Open House at the beginning of each school year. The staff also hosts at least one Family Reading Night each year. These events are used to showcase the building and programs at each building. This is also an opportunity for parents to meet with each teacher. We have Parent/Teacher Conferences scheduled for October. These events are used to discuss the progress of each student. The school social worker works with individuals or groups of students on social issues. Lincoln Elementary School District #27 also employs a school nurse. LESD #27 offers bussing services for students that have an IEP. We also collaborate with Tri-County Special Education Services to provide different outreach programs to families.

Parent Involvement & Community Involvement – Describe ways the school involves families and the larger community.

Northwest has a Parent Teacher Organization that works to raise money for the school. The money is used to enhance services for the students and staff. Northwest has an annual Family Reading Night to encourage families reading together. Northwest hosted a Relay Recess event to educate the students on environmental dangers that could cause cancer. This event involved community volunteers to educate the students on different hazards. Northwest hosts a winter and spring music concert.
